Hi

I have been living here at this address since 2016, I am disabled with many other life threatening conditions, this planning application plans are not how the property is set out, they are old plans that have not been updated. There has been no surveyors attend this property since I've lived here. The landlord has said he wants to demolish the property, so he has put in eviction notice for me to vacate the premises, he has harassed me to leave going as far as to getting his hmo house assistant to lick me out so I couldn't enter, he instructed his unskilled electrical guy to cut all the power to my flat (garden flat) I'm disabled and he fitted coin machine, I'm in the extremely high risk group and the landlord has threatened me to leave during lockdown there is no hot water at this property and no means of cooking food, he had let this unit out for cash in hand to many people before me and now he is saying he did not consent to me using this part of the flat that he was renting out before. He has caused a lot of unnecessary disability discrimination even with his workers he has used in the past have caused an electrical fire, code 1 has been recognised on the property that they tried to hide from all tenants this is the reason why I'm being evicted because I complained how the landlord had put all our lives at risk. So he rushed in an application saying he is demolishing the property to rebuild, even though Camden have not condemned the property, this is an illegal eviction and the landlord is using the excuse of a demolition order that I haven't seen. He has been instructed via a hazard awareness in February this year that he has totally ignored, because of this my life has been threatened with death because of the life threatening situation I'm left in. I reported the stagnant smell of water I. This property and also in his hmo tenants have complained but he said WHAT DO I WANT HIM TO DO ABOUT IT?

No repairs have been done, the landlord consented in writing to me about using other unit and now he says he didn't, these lies and deception by the landowners goes further to the point he told the electrical company there was a weed farm on the premises and that I had moved out. The Onbudsman investigation proves the landowners are deceitful and stop at

nothing to shift there responsibilities. They took £500 from me for electricity bill that they were not paying eon and edf can confirm this. I would like to know if this planning to do the roof is from instructions from the EHO CASE OFFICER who issued notice or, is it an application from owners? We have not been told anything. Therefore I object to this work being carried out because it's part of the plan for an illegal eviction that has caused harassment on many occasions. The landlord has refused reasonable adjustments and also adaption have also been refused, he was saying that planing at Camden will not allow any work. So I would like to know if you are the reason why the landlord was able to refuse my request for adaption. I have it in writing from landlord that planning at Camden will not allow adaption. Is this true?
