Rear Garden:
T1: Semi-mature Beech: Approximately 14.00m. Reduce crown height back to previous and most recent reduction points (approximately 1.50-2.00m).
Reduce lateral and sub lateral growth by approximately 1.50-2.25m.
Thin crown density by 20-25%.  Remove dead wood.
Reason: General maintenance as the tree is growing within close proximity of the building and casts heavy shade in the Summer months.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
