The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: 274/276-A003, 274/276-A005, 274/6-A006, 274/6-A007, 274/6-A008, 274/6-A009, 274/6-A010, 274/6-A011, Block Plan, and Location Plan

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission.

The proposed development is considered to be acceptable in terms of size and design. The ground floor rear extensions are very modest in size- they would match the existing 2 side wings in width and project out by another 2m. They would be subordinate to the host building in bulk and would have appropriate materials with new matching doors and brick façade. The design, scale, and materials of the development would be in keeping with the character and appearance of the host property and wider conservation area.

Special regard has been attached to the desirability of preserving or enhancing the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

Due to the location of the proposed rear extensions, coupled with the significant setback from any shared property boundaries, it is not considered there would be any detrimental impact to neighbouring residential amenity.

No objections were received following statutory consultation. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposal is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the policies of the London Plan 2021 and National Planning Policy Framework 2021.
