### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

FRONT GARDEN: 1 x Hawthorn (T1) - Raise low crown by 1.2m, (secondary branches).

1 x Portuguese Laurel (S1) - Reduce back from footpath by approx. 1.2m.

1 x Robinia (T2) - Reduce lateral and sub lateral branches by approx. 1.5m growing over path to the south.

1 x Yew (T3) - Reduce lateral and sub lateral branches by up to approx. 1.5m overhanging to the south side of the tree.

1 x Holly (T4) - Reduce crown by up to approx. 2m all round, concentrating mainly on the lateral and sub lateral growth overhanging the pavement to shape and balance crown

The Council has considered your notification of intended works to trees dated 31 January 2023 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
