NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

FRONT GARDEN: 1 x Magnolia (T15) - Thin crown density by 20%. Reduce overlong extraneous branches back into main crown structure, up to 1.25m. Raise crown up to 1.5m.

REAR GARDEN: 1 x London Plane (T1) - Reduce back to previous and most recent reduction points (approx. 2.5m all round). Thin inner crown by 15%.

1 x Oak (T2) - Thin crown evenly throughout by approx. 20%. Reduce lateral and sub lateral branches growing to the South over the White House by 2.5m - 3m preserving suitable growth points.

1 x Robinia (T3) - Reduce extraneous overlong branches back into main crown structure approx. up to 1.25m.

7 x Bays (G2) - Reduce back to previous and most recent reduction points (approx. 1.5m). Thin crown density of the group by approx. 30%.

1 x Holly (T4) - Reduce extraneous overlong branches back by up to 1.5m.

1 x Liquid Amber (T5) - Remove broken branches. Thin crown density by approx. 20%. Reduce any overlong extraneous branches back into main crown structure, not more than approx. 1.5m - 2m.

1 x Gleditsia (T6) - Reduce lateral and sub lateral branch structure overhanging the lawn by approx. 1.8m.

1 x Yew (T7) - Reduce crown by approx. 1.3m. Reduce section of the crown overhanging the orchard by 2m. Thin crown density by approx. 25%.

1 x Cherry (T8) - Fell to ground level and grind stump to approx. 3m below current ground level.
1 x Sorbus (T9) - Thin crown density by 20% - 25%.
1 x Norway Maple (T11) - Reduce crown by approx. 1.5m all round. Thin crown density by 20%.

The Council has considered your notification of intended works to trees dated 07 February 2023 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
