Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
T10 - London Plane (right hand side of rear garden - Reduce the crown by approx. 5 - 6 metres in height to a suitable growth point.
This tree has a very large cavity on the main stem from ground level all the way up to 5 metres above ground level. There is a large amount of
weight in the top of the tree which. The tree consists of one tall bendy stem which grows out of the main stem where the large cavity is. (See images)
Our thinking is to reduce the tree significantly in order to retain the tree at a safe size. It would not be possible to reduce the tree by any less due to the bendy nature of the main stem.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
