Identification of Tree(s) and Description of Works

Cockspur Thorn Seq 27 (Highways tree, FO 168) will be laterally crown reduced by 30%, equivalent to 1.5m to be removed from the crown tips and added to the Highways biennial re-reduction regime to control its canopy size in future.

The four eastern-most Poplars Seq 49, 53, 54 & 55 will also be laterally crown reduced by 30%, equivalent to c.2.5-3m to be removed from the crown tips and added to the biennial re-reduction regime to control their canopy size in future.

These proposed operations are to retain the trees rather than felling as they offer a valuable visual amenity screening of the new housing development on Liddlell Road. Removal will only be necessary if the reductions are not successful in preventing future subsidence to the properties on Maygrove Road.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
