- 1 The development hereby permitted shall be carried out in accordance with the following approved plans- Lighting Columns Location Plan, dwg. no 1MC03-

Reason: For the avoidance of doubt and in order to define the approval in accordance with Schedule 17 to the High Speed Rail (London - West Midlands) Act 2017.

Informative(s):

- 1 The proposal is to install 4 (no.) x 8 metre high mounted lighting columns, situated on the northern side of the highway on Granby Terrace Bridge. The lighting columns will replace the existing 4 (no.) lighting columns located in a similar position on the bridge.

The replacement lighting is required to improve highway safety. The lighting columns will be of a similar height and form, and will be located in a similar location, as the existing columns to be removed. Therefore, the proposal does not introduce new amenity effects.

Council's Lighting and Transport officers have no objection to the proposed works. As such, the proposal is considered acceptable in terms of lighting and transportation effects.

The proposed replacement lighting is therefore considered acceptable.

- 2 In accordance with assurances given by the Secretary of State, the applicant is reminded that HS2 Phase 1 Environmental Minimum Requirements must at all times be fully complied within undertaking the works.
