| T1,T2,T3) 3 x pollarded Lime trees at front of property: reduce stem by approximately 3 metres height to original pollard framework. These |
| trees have been maintained as pollards at 2 different heights. My client would prefer to maintain the trees at the original pollard height (see photo) to provide more light to upper windows. |
| T4,T5,T6) 3 x Lime trees on rear garden boundary: Reduce height and width by up to 2.5 metres; all pruning cuts will be made within the previous, most recent reduction framework. |
| T7) Eucalyptus in neighbouring property (12 Aberdare Gardens) on garden boundary with no.14: Remove to ground level. This tree has grown with a significant and disproportionate lean and is structurally unsound. Residents at no.12 and no.14 have young children and have valid concerns about the lean and movement of this tree (see photos). Reducing the crown will not mitigate the risk of heavy leaning stem, the only feasible option is to remove it. |
