T1: Quince: Approximately 5.00m-6.00m: Reduce back to previous most recent reduction points approximately 1.20m. Thin crown density throughout by approximately 20%-25%. Remove dead wood. General maintenance. T2: Willow: Approximately 2.50m: Remove Jasmin advancing into crown (from neighbouring property). Trim overlong, wayward branches back into main crown structure up to 1.00m to reshape crown. General maintenance.
T3: Mature Ash Pollard: Approximately 3.00m: Reduce back to previous and most recent pollard points approximately 0.70m. General maintenance. G1: Fuchsia hedge: Remove honey suckle. Trim to tidy and control encroachment. General maintenance.
G1: Fuchsia hedge: Remove honey suckle. Trim to tidy and control encroachment. General maintenance.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
