	Chair of Planning Subcommittee)			Last year we suggested that you give consent at most for 1 table and 2 chairs (facing along the building line) until 21:00 hours. However, the congestion in the Yard has increased so that there is no longer room for safe passage nor pedestrian escape if any furniture at all is placed in the main through-route. This is the route that we have shown in the overhead view of Neal's Yard, below.

				We urge the council to review the whole situation regarding crowds and clear passage in Neal's Yard. We believe that there is very little space outside any commercial premises that can now be allocated for tables & chairs and still leave fair amount of room for public use. Residents have difficulty getting to their front doors at times. And, disgracefully, the Yard cannot be used as a route by disabled people when it is busy.
				Neal's Yard is public highway. Anyone should be able to walk, or be wheeled, from Monmouth Street to Shorts Gardens and back, without having to dodge around queues and people eating.
				Below is a photograph showing what happens even on a cold day in the Winter. In the Summer it is far worse. You can see how difficult it is for pedestrians to fit past the queue for 26 Neal's Yard, which is opposite 'Barbary Next Door', even when that queue is not very busy. The furniture outside 'Barbary Next Door' makes the pinch-point harder to negotiate, even before people are sitting at it, so we believe that it is no longer responsible for the council to allow any seating outside these premises.

1. Licence Condition 36 forbids any noise from the operation that causes a nuisance. Neighbours complained throughout last year about the noise from customers outside these premises causing public nuisance, in breach of the licence. It is not possible for the applicant to control noise from customers any further, so any grant of a licence for outside dining would cause a continuation of the breach of the alcohol licence, which would be unlawful.

2. The Licence does not allow the sale of alcohol for consumption outside the premises' demised area. Any service of alcohol to customers outside is therefore unlawful in normal circumstances. There is a temporary, post-Covid relaxation of this rule only until 30/09/23. So any grant of a licence for unrestricted outside dining beyond this date would cause a breach to the alcohol licence, which would be unlawful.

Finally, we must note that the premises have not operated in good faith. Sadly, for a long time, as your enforcement team knows, they have operated more furniture than consented, and later than consented, despite many complains and appeals from their neighbours.

This behaviour leads us to conclude that the applicant is not fit and proper to hold a licence.
