T1 Damson - Rear garden. Proposed Works: Reduce branch overhanging 112 St Pancras Way property back by 1 meter to suitable growth point and remove deadwood with a formative branch tip renovation for better fruit production. T2 Plum Species - Rear garden. Has a history of previous heavy crown reductions. Proposed works: Renovate upper canopy with crown cleaning, removing dead, rubbing and crossing branches. Reduce upper canopy by 1.5 meters for better fruit production. T3 Plum Species - Rear garden. Suppressed by T2. Proposed works: renovate canopy by crown cleaning, removing dead, rubbing and
crossing branches and water shoots to allow more light penetration for better fruit yield.
