The council granted permission to remove the lime tree ref 2022/4174/T dated 5 December 2022. Due to practical considerations regarding the removal of a third-party owned tree the work proposed is now to install a tree-root barrier rather than remove the tree. The reasons for the work are as a before, damage to the property.

The works are more fully described in the method statement.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
