T1, T2, T3, T4, T5. Five Sycamore trees on the road frontage to the property.

These are mature trees that we have maintained over the past 25 years, or so. 3 of the trees are on sloping ground and are close to the building. It has been an insurance requirement to maintain these trees, which we have carried out with a view on keeping their amenity value, as well as controlling the leaf area (and presumably the water requirements)

Specifications: Crown thin by 30%. Reduce height by 2-2.5m. Reduce spread by 1.5-2m. Reduce Ivy to previous level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
