We would like to reduce the mature London Plane tree back to previous reduction points -this is about 2-3 metres. Leaving furnishing growth for crown continuity. We would also like to thin the canopy by about 10-15%. The tree hasn't been pruned for many years and is in need of pruning as it is outgrowing its location. It would also minimise possible root damage to properties. Having a reduction will also allow more light in to the gardens and properties.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
