The amount of anti-social behaviour happening in and around the towers due to it being totally open compared to other local places that have some protection is out of control.</p> <p>There are regularly groups of people on the stairs doing drugs/smoking or even worst. The lift has been unusable for years due to it being filled with needles and bottles and groups hanging around there, you will also find it covered in urine and feces.</p> <p>Clarion over the years have not done a great deal at all to try and deal with this or to even try and reduce the impact on us and the surrounding area. The towers are too accessible for anyone to come in and just settle in, and Clarion and the Police either struggle or have not acted strong enough to deal with it.</p> <p>The safety of the residents and the surrounding area has been and is at risk on a regular basis. The residents and I are intimidated on a daily basis to leave our flats. Random people just appear on our floors and camp out for some time days. We dont even have any CCTV for our protection or the surrounding areas.</p> <p>The area is a very nice place and its a real shame that this is a hive for anti social behaviour all due to it being so open for anyone to come on and camp.</p>

They sit in the stair wells drink alcohol take drugs, eat food, make lots of noise and are abusive to residents, they refuse to move out of the way which is very threatening.</p> <p>We have been subjected to sexually explicit graffiti which has been removed on more than once</p> <p>We also have open drug dealing happening in the grounds of the estate, with drug addicts waiting to buy drugs who then proceed to take the drugs, leaving their drug paraphernalia all over the estate. We have drug users and alcoholics using are garden area to urinate and defecate in.</p> <p>There have been 2 serious incidents where residents have been seriously attacked, by these intruders one in 2021 and another on 28th March 2023 where the police have been involved supporting our residents who are victims of serious crime.</p> <p>As a community we have young children, families and elderly residences, the tenants of The Towers are decent people whose home has been overrun by people who have no connection with the block. There seems to be a free for all for gangs to attend our estate as we have no security around our block. Anyone can walk into and through our small estate at any time, we have also had issues with dog walkers using our garden as a park and not picking up after their Dogs.</p> <p>As the block is situated on the corner of Dartmouth Park Avenue in an L shape these intruders cannot be seen from the road by Police patrols</p> <p>I feel the submitted plans are essential to enhance the safety of us residents at The Towers so we can feel safe in our homes, they also present an improved sympathetic updated look to the estate.
