We inspected this site and noted a large Sycamore with an acute lean towards neighbouring garden. The tree itself is heavily impacting onto the boundary wall which is showing signs of structural defects.

We advise:

T1 - Approx. H17 S10 DBH35 - Sycamore

Fell as close as possible to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
