Identification of Tree(s) and Description of Works		
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out		
Eucalyptus (T1) - reduce crown by 4m on all aspects, ensuring good clearance from the building. The tree is very big, overhangs the roof and school playground behind. It is within 5m of the property. Pruning will restrict root growth and let more light into the building and garden.		
Pear (T2) - reduce crown by 2.5m on all aspects to reduce end loading on over extended branches and restrict root growth. It will also let more light into the garden.		
Mimosa (T3) - reduce crown by 2.5m in height and 2m on lateral branches. The tree is very big and within 4m of the property. The pruning will restrict the root growth and reduce the chance of branch and tree failure, given the fact that mimosa trees are shallow rooted and prone to branch failure. Two healthy branches have failed and fallen in the past month.
