Details of the pre-application advice received

The proposal involves the creation of a 'work café' at the ground floor of 2 Triton Sq on the Euston Road elevation. This elevation is comprised of 4 bay units and the proposal in question relates solely to the bay unit that is second from the left when observing the building from Euston Road. The proposal also involves the installation of 2 ATM units, automatic swing door, access ramp, fascia signage and internal digital screen. The proposals would not involve a change of use as the existing and proposed use of the site is within Class E.

The principle of creating an active frontage along the Euston Road elevation is supported in principle by the Council. It would enhance the currently hostile environment for pedestrians and create natural surveillance. The Council would encourage the activation of the entire ground floor frontage rather than just one portion as is currently proposed. The replacement of the frosted glass with clear glazing is supported. The installation of an access ramp and the revised automatic swing doors which would be aluminium framed are considered sympathetic to the host building and are supported.

The fascia sign located on a black metal beam is considered acceptable in principle and would need to be subject to an advertisement consent application.

The installation of a digital screen internally would not require planning permission and would thus not need to form part of a formal application and no objection is raised.

The proposals have been reviewed by the Met Police's Designing Out Crime Officer who has raised concerns over the installation of ATMs. They have encouraged the ATMs to be located internally within the fabric of the building and the corner plot should be designed out to prevent would-be criminals from loitering out of sight in the corner. The revised plans show the corner plot being designed out with planters and a sandwich board, however the preference would still be for the ATMs to be located internally in the building. This would also create a cleaner and less cluttered appearance on the building elevation.

In conclusion the proposals are in principle supported by the Council. The activation of the whole frontage is encouraged if this can be explored. The location of the ATMs to be within the building fabric is encouraged rather than externally for design reasons and to reduce potential crime. The proposed fascia sign is considered acceptable in principle and would require advert consent.
