FG 22 Fairhazel Gardens, Lime tree Seq 1: TPO application for General Prune ('GP1') inc prune back branches from adjacent building (no.22 Fairhazel Gardens) leaving 2-3m clear. Tree is touching building and the scheduled re-reduction is on hold over the summer until next reduction season begins (i.e., from October 2023).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
