T010 London Plane

Previously pollarded at 6m. X2 very large dead stems overhanging footpath

Crown reduce by 3m to suitable pruning points.

T027 Sycamore

Peeling bark from base to 4m on main stem, 2 out of 3 stems dead. Decay at main union.

Fell to ground level.

T033 Lime

Trees damaging retaining wall. Recommend management system of reducing crown every 2-3 years to retard stem and root growth to lessen impact on retaining wall.

Crown lift to 3 m for pedestrian clearance.

Crown lift to 5.2 m for highway clearance.

Crown reduce by 3m back to previous.

Remove deadwood - greater than 25 mm.

T034 London Plane

Trees damaging retaining wall. Recommend management system of reducing crown every 2-3 years to retard stem and root growth to lessen impact on retaining wall.

Crown lift to 5.2 m for highway clearance.

Crown reduce by 3-4m back to previous pruning points.

Remove deadwood - greater than 25 mm.

T008 London Plane

X1 very large cavity at 2m from previously removed stem, very large cavity at 4m main stem from broken limb with decay extending down into main stem. Previously heavily reduced most likely in response to broken limbs. Large dead stubs from previous pruning works overhanging footpath and road.

Crown reduce by 4-5m to growth points were possible to reduce crown weight.

T022 Lime

Unsure of ownership. Large dead stem at top of tree an 2nd stem poor condition. Previously reduced.

Reduce top by 3m and reduce side by 1-2m to create shape, remove deadwood.

T036 Cherry x2

Cherrygrowing out of base of wall, will be causing damage which will only get worse.

Fell tree.

T006 Lime

Previously reduced. Cavity at 4m main stem but unable to see extent of decay. Minor deadwood.

Crown reduce by 2-3m back to previous points of reduction.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
