Proposal:

FRONT GARDEN: 1 x Lime (T1) - Reduce all aspects of crown back to previous points of reduction.

1 x False Acacia (T2) - Reduce all aspects of crown to 1m - 1.5m below previous points of reduction and shape. Install x 1 cable brace (cobra system) 2/3rds the height of the tree between the main stem and the secondary stem.

1 x Lime (T3) - Reduce all aspects of crown back to previous points of reduction.

1 x Lime (T4) - Reduce all aspects of crown back to previous points of reduction.

1 x Lime (T5) - Reduce all aspects of crown back to previous points of reduction.

The Council has considered your application dated 17 March 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and

standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
