T1) Robinia at front of property: Reduce lateral growth only by up to 2 metre branch lengths; retain height of tree; crown lift to 3 metres height.
G1) Group of Privet, Elder & Ivy directly adjacent to T1: Remove to group level.
T2 & T3) Small Buddleia & Elder in rear garden: Remove to ground level.
The garden is being re-landscaped and these trees have very low amenity value so not worth retaining.
