The Council has considered your application and decided to **refuse** planning permission for the following reason(s):

1 Reason for Refusal

The proposed communications equipment located at roof level, by reason of its location, size, number, height and design, would result in visual rooftop clutter that would detract from the host property and be detrimental to the streetscene. It would

harm the significance of the conservation area, failing to preserve the character and appearance of Hampstead Conservation Area contrary to policies D1 (Design) and D2 (Heritage) of the Camden Local Plan 2017 and policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018.

2 The cabinets on the site would create a visual obstruction less than a metre away from windows, causing an undue sense of enclosure and harming outlook, contrary to policy A1 of the Camden Local Plan 2017.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2021.
