Rear Garden - T1 - Ash Leaf Maple - Continues to lean more onto wall and concerns with knocking wall over in wind. Neighbours had new wall built that may have undermined the trees roots Fell to ground level			
T2 - Plum tree - Reduce height to previous reduction points by approx 1m			
T3 - Bay tree – Outgroing location. Hard prune by reducing the crown by approx 1m. This will leave it bare for a period of time and should recover as smaller tree.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
