Lombardy Poplar T1 - Reduce the lower half of the crown(up to 12 metres high) all around by up to 1.5 metres and back to previous points of reduction

Remove all epicormic growth from stem and main branches up to a height of 6 metres above surrounding ground level.

Remove all dead, diseased and damaged branches throughout the crown as required.

Reduce crown on building side to give 2.5 metres clearance.

Lombardy Poplar T2 - Reduce the lower half of the crown(up to 12 metres high) all around by up to 1.5 metres and back to previous points of reduction.

Remove all epicormic growth from stem and main branches up to a height of 6 metres above surrounding ground level.

Remove all dead, diseased and damaged branches throughout the crown as required.

Lombardy Poplar T3 - Reduce the lower half of the crown(up to 12 metres high) all around by up to 1.5 metres and back to previous points of reduction.

Remove all epicormic growth from stem and main branches up to a height of 6 metres above surrounding ground level.

Remove all dead, diseased and damaged branches throughout the crown as required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ~$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
