Remove regrowth (approx. 2-3m) back to original growth points as per previous practice.

Tree work is to be undertaken to improve form and increase safety in accordance with good arboriculture practice and maintain the future well being and growth of the trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
