Proposal: Alterations to fenestration to the front elevation.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan, Block Plan 01, 02A, 03A

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission.

The proposal alterations are considered acceptable in terms of scale, design and materials; and would not appear incongruous in this setting. The installation of white powder coated aluminium framed bi-fold doors to the front elevation is considered acceptable given there would be very little change to the appearance of the host property from the public realm. The proposal also follows similar works carried out to the other flats within Dudley Court.

The location of the bi-fold doors is hidden by an existing balcony wall. The opening created is not entirely new, rather some sections of the existing opening shall be made larger to accommodate the bi-fold doors in place of the existing window and door arrangements.

The works are considered to improve the amenity of the occupant by making their existing terrace space more usable and accessible. Given the nature of the proposals, there is not considered to be any negative impact on neighbouring residential amenity in terms of loss of light, privacy or outlook.

No objections were received prior to the determination of this application. The planning history of the site and surrounding area were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1 and D1 of the Camden Local Plan 2017. The proposed development also accords with The London Plan 2021, and the National Planning Policy Framework 2021.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
