The proposal relates to the removal of a section of wall to facilitate access for piling rig to enable pile foundations to be constructed for the approved single storey rear extension. The piling solution is required as the Soil Investigation Report advises that there is made up ground up the 3m deep, traditional trench foundations are not feasible at this depth.
All works will be carefully undertaken by hand, all materials coping stones and bricks will be retained on site and carefully protected for re-use in reinstating the wall as existing following completion of the piling operations.
