Proposal:
FRONT AREA POND STREET: 1 x Lime (T006) - Crown reduce by 2m - 3m back to previous points of reduction.
1 x London Plane (T008) - Crown reduce by 4m - 5m to growth points were possible to reduce crown weight.
2 x London Planes (T010) - Crown reduce by 3m to suitable pruning points.
SIDE AREA FLEET ROAD: Group of Limes (G033) - Crown lift to 3m for pedestrian clearance. Crown lift to 5.2m for highway clearance. Crown reduce by 3m back to previous points.
Group of London Planes (GT034) - Crown lift to 5.2 m for highway clearance. Crown reduce by 3m - 4m back to previous pruning points
2 x Cherries (G036) - Fell to ground level.

The Council has considered your application dated 25 April 2023 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
