Replace asphalt front steps with Victorian style tiles. The current asphalt steps are both ugly and also uneven (we think the asphalt was applied in the 1970s). Puddles form on the uneven steps, which turns to ice in winter, making them very unsafe. We would also put tiles on the steps leading down the basement well at the front of the house and the small porch area in the basement well. The steps leading to the basement well are cracked, uneven and also very unsafe.

We would also like to install a handrail along the front steps. This is because the steps are steep and quite unsafe and unnerving - especially for elderly people. The handrail would also be consistent with a Victorian style.
