Tree Type - Elder (Sambucus sp)

Approx Height - 3m

Approx Spread - 1.5m

Location - as per map

Service - Fell

Work required - Fell as close to tree's current ground level as possible and leave the stump in the ground

Reason - Tree in poor form with major deadwood & cavity at base

Tree Number - T4

Tree Type - Silver birch (betular pendula)

Approx Height - 8m

Location - as per map

Service - Cut Back

Work required - prune all encroaching branches away from building to give a minimum of 1m clearance

Reason - as part of continued maintenance

Tree number - T5

Tree type - Lime (Tilia Cordata)

Approx Height - 15m

Approx Crown Spread Diameter - 7m

Location - as per map

Service - Repollard

Work required- Re-pollard back to previous pruning points by removing approximately 3-4m from height and 2-2.5m

from sides. Remove epicormic growth

Reason - As part of continued maintenance, to form a more compact crown and reduce debris and encroachment

over adjacent roads, street furniture and communal garden

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
