Rear Garden: T1: Mature Corkscrew Willow: Approximately 7.00m. Reduce back to previous and most recent reduction points (approximately 1.25m) whilst preserving a suitable amount of furnishing growth to ensure crown continuity. Thin crown density by approximately 20%. Remove dead wood.  Reason: General maintenance to help manage the tree at reasonable dimensions for its location, increase light levels and reduce hazard potential.				
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
