The proposal is for the conversion of an existing storage space into a new bedroom, along with associated external works such as the replacement of an existing access door with a new window. A planning officer confirmed as part of the pre-planning process that this did not constitute a change of use. Excerpt below:

Internal works to a dwelling do not require planning permission and the creation of a new bedroom does not constitute a change of use. The works to the floor of the storage area to accommodate the bedroom would not require excavation, so do not require planning permission either. Therefore, the element of the proposal that requires planning permission is the replacement of the door to the storage area with a new window, which the plans state would be box sash.

The works are needed as I am a single parent with two young children who live part of the time in the property. They currently share a room and this will give them both their own bedroom.

A structural engineer has been consulted and provided advice on the works, and trial holes have been dug to confirm no underpinning is required. Access to the property for the works will be through my own private gate.

In advance of works commencing I will be requesting approval from the other joint freeholders to the house, though after some initial consultation I dont expect any issues.

The new window (the reason planning permission is required) will be a timber double hung box sash window to match in detail the existing one above it.
