

STATUTORY DECLARATION

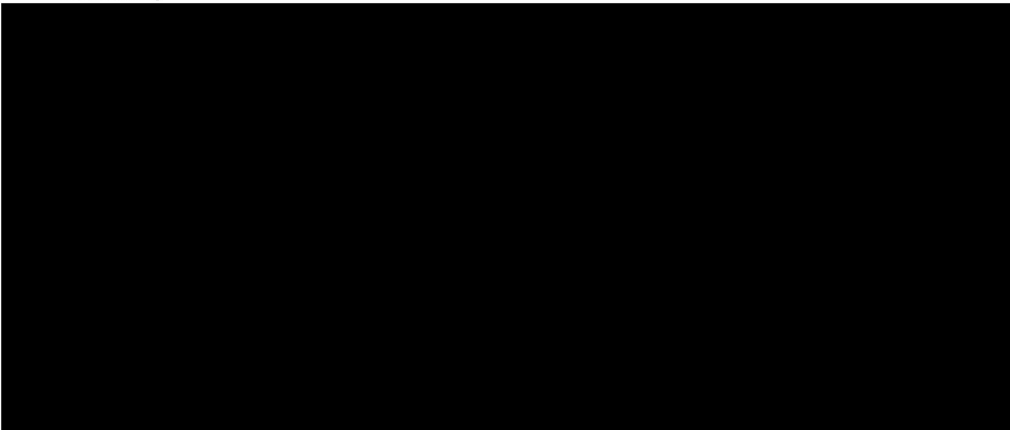

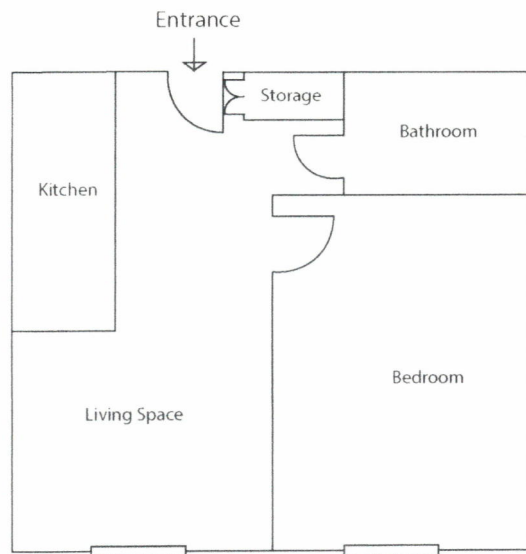
Flat 3 267 Eversholt Street, NW1 1BA
(First Floor Front)



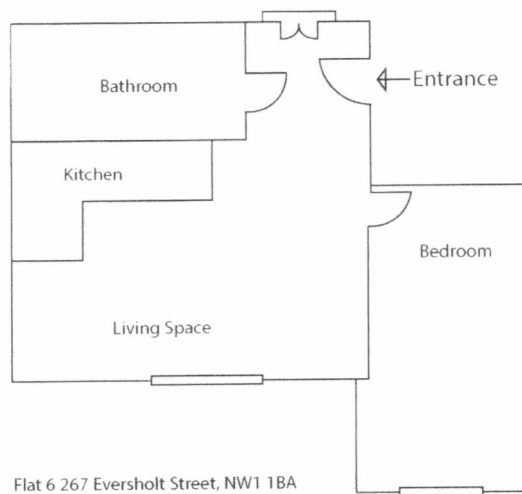
Flat 4 267 Eversholt Street, NW1 1BA

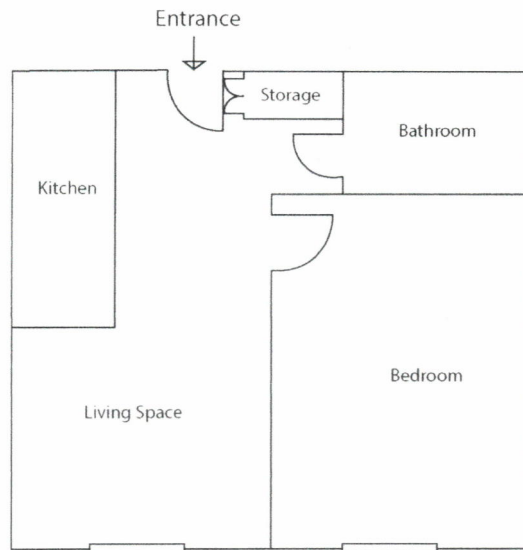


Flat 5 267 Eversholt Street, NW1 1BA
(Second Floor Front)

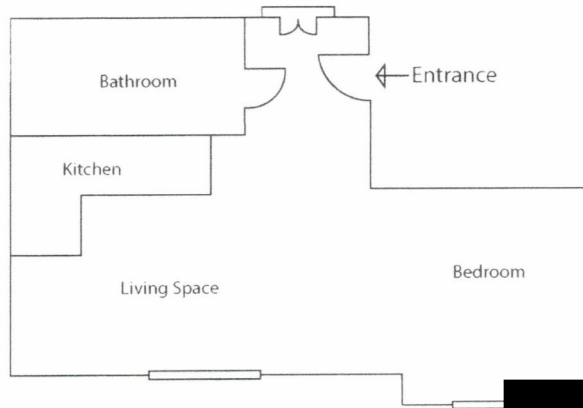


Flat 6 267 Eversholt Street, NW1 1BA

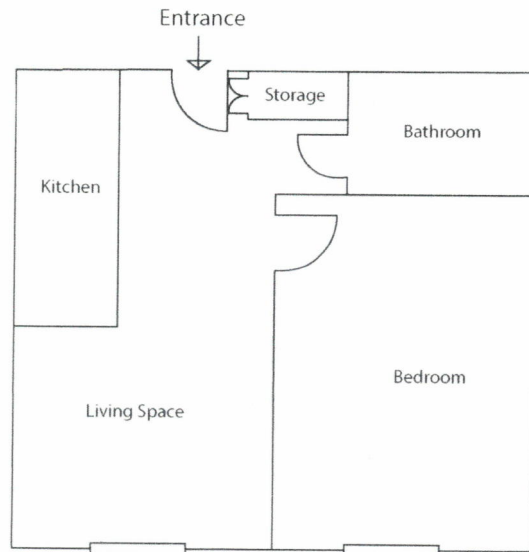


Flat 7 267 Eversholt Street, NW1 1BA
(Third Floor Front)

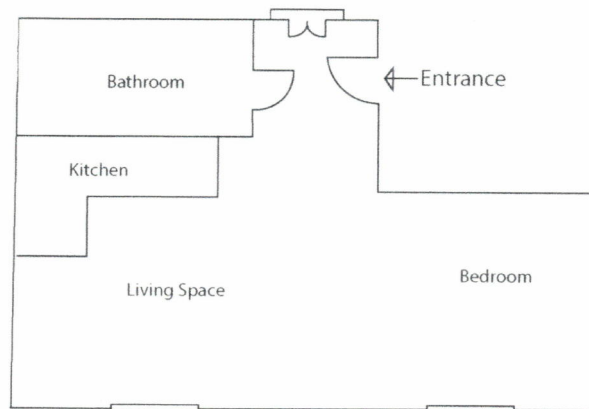


Flat 8 267 Eversholt Street, NW1 1BA

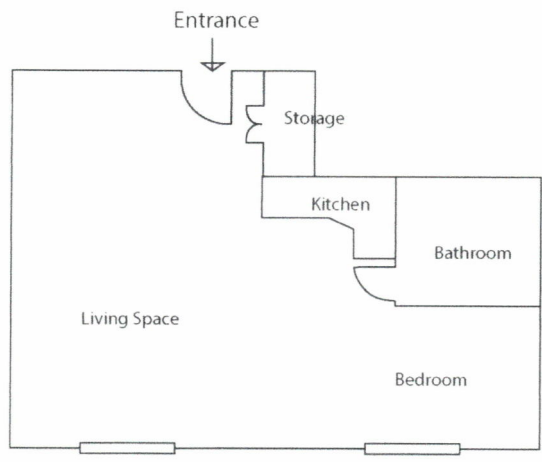


Flat 9 267 Eversholt Street, NW1 1BA
(Fourth Floor Front)

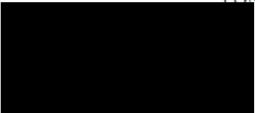


Flat 10 267 Eversholt Street, NW1 1BA
