The proposals submitted here represent the replacement of all the existing windows with double glazing and the addition of a boiler flue extract in the side elevation, and kitchen extract to the rear elevation of the first floor flat, Flat 1, at 172 Regent's Park Road.

The proposed timber sash windows to the front elevation will be made to match the existing proportions and joinery details of the original sash windows, retaining the profile and thickness of frames and glazing bars whilst accommodating slimline double glazed panes. The existing un-original mullion in the corner window will also be omitted and replaced with a single pane.

In the rear elevation the large hybrid window will be replaced with a sash window, made to match the existing proportions and joinery details of the existing top pane of the original sash in this location. Again, matching the profile and thickness of frames and glazing bars whilst accommodating slimline double glazed panes. We will also reinstate the vertical glazing bars which will be integral to the glazing, as opposed to applied.
