Liaise with teams and departments across the Council to advise and facilitate their GIS and mapping needs. Providing geospatial support, including recommendations for efficient service outputs and processes. Including advising on best practice for data collection and governance.

Investigate, create, and maintain centralised geospatial datasets including sourcing new and updated data from our geospatial partners and third parties.

Provide support to GIS Data Owners and Custodians to build and maintain service specific geospatial data and visualisation, enabling self-service of their data where appropriate.

Provide basic training to internal users on MapInfo Professional and QGIS as well as basic spatial analysis techniques including creation of training materials.

Use data visualisation tools including interactive mapping and bespoke map creation.

Ensure Data Governance processes are followed to maintain the corporate GIS Data Catalogue.

Liaise with geospatial experts to ensure licensing requirements are adhered to.

Promote and follow the ideas and principles of Camden's GIS Strategy and Data Strategy.

Provide expert spatial analysis and data creation to assist in the delivery of service objectives.

Contribute to help define and update existing geospatial related governance documents and procedures to meet strategic, operational, and legislative needs covering aspects such as data standards, security, and permissions.

About you

The successful candidate will demonstrate a strong understanding in the IT infrastructure, configurations and the IT applications and service processes used to manage geospatial information.

You will be familiar with techniques for identifying, gathering and validating customers' needs in the delivery of IT services and also the application of automated (software) tools.

The right individual will have the ability to manage customer expectations and ensure effective communications with colleagues and customers throughout the service.

You will be familiar with the management and maintenance of large data sets including but not limited to Ordnance Survey based products.

You will be passionate about the importance of geospatial data as an enabler for the organisation and its potential to give insights into the linkages between people and place.

You will be able to manage competing work priorities effectively and ensure an efficient working environment.
