The extension of the rear roof slope and new front roof slope together with a new flat roof to cover the existing fire exit for No.9 and No. 10 Lincoln's Inn Fields. The new roof will require the left party parapet wall to be extended by 1,200mm to accommodate the new roof. The brickwork is to be reclaimed and to match existing in all respects. There will also be the introduction of a new roof hatch to the new flat roof to provide access for maintenance. Natural slate will be used for the roof slopes to match existing. The fire exit will still be in use.
