With the Intention to start with Flat 1 and later complete the same work to Flats 2,3,&4. Design Inspiration: With the original windows being steel, we have opted for an aluminium alternative. With UPVC also being a modern alternative, we have opted for aluminium as its thinner frame and section will help maintain the original design intention of the building. The thinner section will help recreate the curve as accurately as possible using 3 individual frames. The aluminium windows are also heritage inspired, furthering our attempt to maintain the façade of the building. The double glazing and lower U Value from all of the materials involved, will help make the building more sustainable. Site Location: Winslow Court is located at 100 Fordwych Road. The Corner property, at the intersection of Mill Lane and Fordwych, shown on the map above by the red pin.
