Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- Plum tree (T1) fell to ground
- Yew tree (T2) fell to ground

The garden has additional trees: T3, T4 and T5. T3 is close to T1 and much taller than T1 and having both of them limits light access to the garden.

These trees are at the end of the garden and they provide significant amount of shadow (the yew being an evergreen to the lower ground flat which has already limited access to light. T2 in particular is already placed in the corner with 2 tall buildings so light to ground is already very limited and it's impossible to grow anything in that corner.

I would like to replace both with lower bushes of raspberries and blueberries and maybe build a greenhouse at the end of the garden but that's not in scope for this request. Clearing the space, cultivating the ground and be able to start fertilising it's my main objective for the time being. The garden is south facing but having those two tree in the way blocks most of the light coming in for the majority of the day

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
