

Network Building – DRIVER SITE RULES

- Delivery vehicles are to EXIT the site from site pit lane (Whitfield St.) turning RIGHT onto Howland St. This is the correct direction to pull out of site.
- Follow exact instructions from traffic Marshall's.
- Obey all instructions given by the sites traffic Marshalls.
- The site speed limit is a maximum of <u>5 mph</u>.
- Do not use a mobile phone whilst driving.
- Do not sound the horn or over rev your engine.
- Wheel wash facilities are available.
- Loads must be sheeted when leaving site.

Penalties for Deviating from Agreed Routes

- 1. Drivers if a driver is found to deviate from the planned route, they will no longer be able to deliver to the site again.
