BANK TRANSFER

Please pay at the National Westminster Bank, Hampstead Village Branch, our account name is London Borough of Camden, sort code 50-30-03, account number 24312819. Always ensure you quote your business rates account number.

POST OFFICE

You can pay by cash, cheque or debit card at any Post Office. In order to make a payment, take this bill to any post office. Please ensure you keep your receipt as proof of payment. You need to allow at least 3 working days for the payment to reach your account. Cheques should be made payable to "Post Office Ltd". There is no charge for this service.
