



EXISTING SKIRTING TRUNKING AND SOCKET OUTLETS TO BE RETAINED AND REUSED. UNABLE TO SURVEY DUE TO HEAVY FURNITURE BLOCKING ACCESS. CONTRACTOR TO SURVEY AND CONFIRM SOCKET OUTLET AND DATA PROVISION.

ALLOW TO REINSTATE DOOR ENTRY/INTERCOM AND THE EMERGENCY ASSIST ALARM TO THIS POSITION. PROVIDE UNSWITCHED FUSED CONNECTION UNITS (4No.) & 5No. (BLUE) DATA + 2No. (WHITE) DATA OUTLETS AT THIS POSITION.

DB 49 TO BE REPLACED. ALLOW FOR NEW AND RETAINED CIRCUITS + 25% SPARE WAYS.

NEW SKIRTING TRUNKING + NEW SOCKET OUTLETS.

EXISTING DADO TRUNKING OUTLETS RETAINED AND RE-FED FROM DB49. CURRENTLY FED FROM DB 50/3 IN CORRIDOR G9401N 50 GORDON SQUARE.

EXISTING DADO TRUNKING RETAINED AND MODIFIED. 2No. EXISTING DSSOs RETAINED AND RE-FED FROM DB49. CURRENTLY FED FROM DB 50/3 IN CORRIDOR G940 IN 50 GORDON SQUARE.
