I am responding to Planning Application – 2023/2333/T. It seems there is a clerical and administrative error to allow 21 days for residents to comment. The application was registered on 8 June 2023. However, comments are only allowed until 7 June 2023 – the day BEFORE the application was registered.

As a result, I am sending my concerns over this application via email. I do not support the removal of any trees from Kilburn Grange Park. Firstly, the residents of the neighbouring new builds – Park Place/Espalier Gardens and the Arbor Collection – were not consulted. Secondly, this greatly impacts the privacy of the residents within these apartments. And lastly, but most importantly, the beautification of the park becomes greatly diminished from the removal of these trees.

Please do NOT let this application proceed.
