However, this permission request seeks a 3 months installation for advertising purposes which has no material benefit to residents.</p> <p>A big concern for me is the huge and constant footfall at dizzying proportions that we residents already endure. As someone who's sensitive to visual and auditory noise, I feel constantly over-stimulated. Also too, is my increasing safety concern from the blatant drug dealers (and takers) milling around menacingly, targeting the hundreds of visitors at Centre Point Piazza.</p> <p>I want to see better protection for local residents, so we feel safer in our neighbourhood.</p> <p>I hope we can be included in early discussions, and help find win-win solutions that benefit residents and Camden Council.</p>
