T1 - Cherry - Sympathetically reduce height of specific extension growth by approx 1.5 to maintain as smaller crown.
T2 - Eucalyptus – Significant lean - Fast growing heavy trees and over several years this tree will become dangerous due to the excessive weight of the stem in relationship with the lean Fell to lowest upright sucker 1m from base
T3 – Plum Tree – Lightly prune in branches by approx 1m growing over Sambuca Elder to try and encourage Elder to grow straight.
T4 - Bay tree - Reduce height by approx 1.5-2m and shape
