It is a Cuprocyparis leylandii. It has had the top of its trunk lopped off and takes on an awkward shape now. It is currently about 3.5m high. There are two large trees next to it - a sycamore and a horse chestnut. And further along the fence boundary are two more leylandiis. We will be leaving all the rest alone.

We would like to remove this particular leylandii and plant 3 small trees of one of the following instead:

-Prunus 'Amanogawa' -Amelanchier lamarckii -Betula utilis jacquemontii 'Snow Queen'

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
