Proposed Work:

PLAYGROUND AREA: 1 x Magnolia Grandiflora (T1) - Reduce crown by approx. 1.5m - 2.5m (30%) all round. Ensuring sufficient clearance of the building and heating flue, approx. 1.2m.  
1 x Cherry (T2) - Section fell to ground level.  
1 x Cherry (T3) - Reduce crown back to previous and most recent reduction points up to 1.25m.


The Council has considered your notification of intended works to trees dated 23 May 2023 and does not wish to object.
