Response 2: The LED light does not face the residential block; they can only see the back of the boxed screen, as the front of the screen faces the office space. There are no adverts, just the BBC news and sport showing (BBC channels do not show adverts). The vinyl wrap of the screen does not promote anything currently, and simply just has the building's logo on it. The screen has been funded solely by the Landlord to help enliven the piazza space and for the benefit of the local community and retailers. The Screen comes on at 8am and turns off at 8pm. During Summer months these times are within natural daylight hours, so therefore would have minimal light pollution.

We have security onsite 24/7 and in the event of anti-social behaviour they go out and move people on and report any crime to the Police. A Security Officer sits in reception 24/7 and looks out to the piazza space to monitor the space along with an officer who is in the control room viewing CCTV around the building 24/7. In the day (8am-6pm core hours of the screen) we have a team of 3 receptionists and a security officer in the reception who all monitor the piazza and reception and report any concerns. We would be interested in having evidence of the screen noise within the flat/s, we are not sure if you have evidence of this so that we can perhaps understand, as we do not feel it is the case. We understand it may be heard with windows / balcony doors open but not at a great level, also that is like anywhere if you have your windows open you will hear noise whether that is from the public / transport / church bells etc.

Central Saint Giles office building has always accommodated and helped both Private and Matilda House residents over the last 12 years, although we are not the managing agents (London Residential Management manages the Private block and Clarion Housing manage the Matilda block). The residents of Matilda House and the Private block will know this and as we have been responsive to many requests over the years and helped various residents or advised.

We fully understand how disruptive local works have been in the area, with the building works at Castlewood House / Centrepoint / Crossrail however we feel having our screen up is nothing in comparison to noisy building works, 7 days a week. Central Saint Giles is a mixed-use development, we have retailers, residents and offices, so we often need to find the right balance for all. St Giles Court and Tottenham Court Road has no relation to Central Saint Giles building. We have no buskers on our piazza space, nor allow it as we have security 24/7 who would move them on. We believe this response is directed at another location. Our LED screen is also not on 24/7, like the permanent fixture at Outernet near Tottenham Road Tube Station which has been granted.

The LED screen may attract more footfall to the piazza and then into our retailers. However, the outside chairs and Astro turf are put away by 6.30/7pm each evening, so there is nowhere to sit thereafter, so the additional footfall may then go into retail units or leave the space. The screen is then off by 8pm and barriers place around it by security.
