Oak (T2) - Reduce crown to points of previous reduction (2m approx. reduction, trees approx. current height 10m (TPO tree) reasons for work This is routine maintenance of this tree and regular crown reductions have been carried out for over 20 years to contain the growth of this valuable tree growing close to buildings and the public highway

Cherry (T1) - reduce by up to 1m beyond previous points of reduction

Laburnum (T3) -fell. This small tree is growing against the boundary wall and has been supressed by the Oak

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
